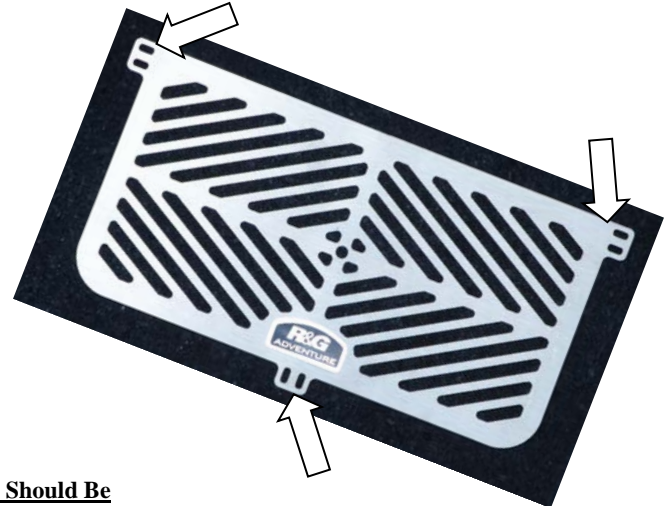
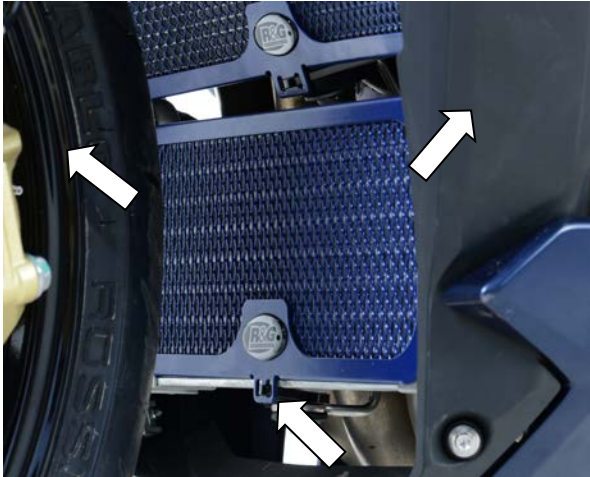




Fitting Instructions for SCG0003 Oil Cooler Guard
Radiator Guard - BMW S1000RR 2010-
& BMW S1000R 2014-

In This Kit There Should Be
1x Oil Cooler Guard
6 x Cable/Zip Ties
2x 100mm Lengths of Foam

- To fit the oil cooler guard to the bike cut the foam strip provided into 10mm wide pieces and stick them to the back of the radiator guard frame, so that they sit between the radiator guard and the radiator. The two cable ties go through the slots at the top of the oil cooler guard and around the mounting brackets of the oil cooler as arrowed in top pictures. At the bottom use the remaining cable tie to tie the oil cooler guard to the bottom of the oil cooler frame as arrowed in top pictures.
- Extra cable ties have been included in the kit in case of any future requirements.

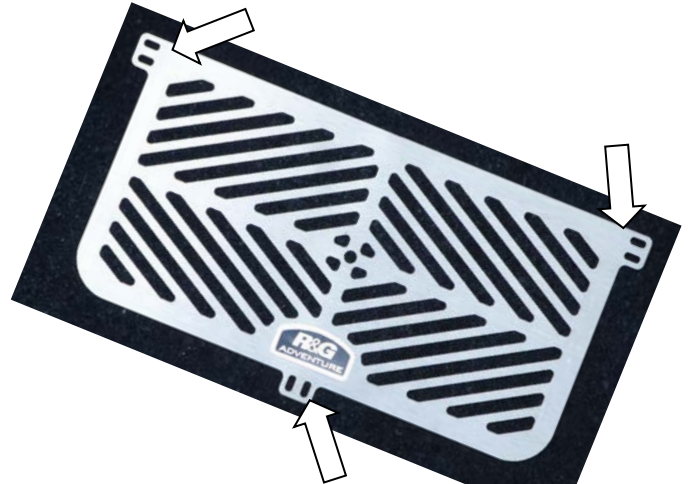
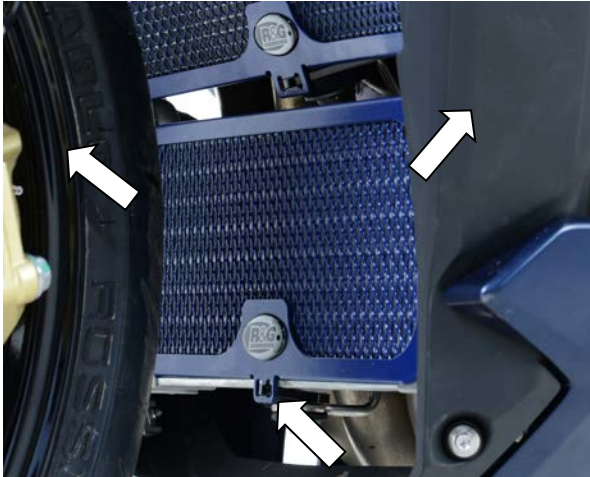

Le kit doit contenir :
1x Grille de protection radiateur
6 x colliers de serrage
2x 100mm Bandeaux autocollants

- Couper la mousse autocollante en bandeaux de 10mm de large et collez-les au bas du cadre de support protection radiateur, de façon à ce qu'ils se retrouvent entre la grille de protection et le radiateur.
- Les 2 colliers de serrage doivent passer à travers les fentes sur le haut de la grille de protection radiateur et autour des supports de fixation du radiateur (photos du haut). Pour le bas, utiliser le collier restant pour serrer la grille de protection radiateur au bas du cadre support comme sur les photos du haut.
- Des colliers de serrage supplémentaires ont été inclus dans le kit au cas où vous en auriez besoin ultérieurement.

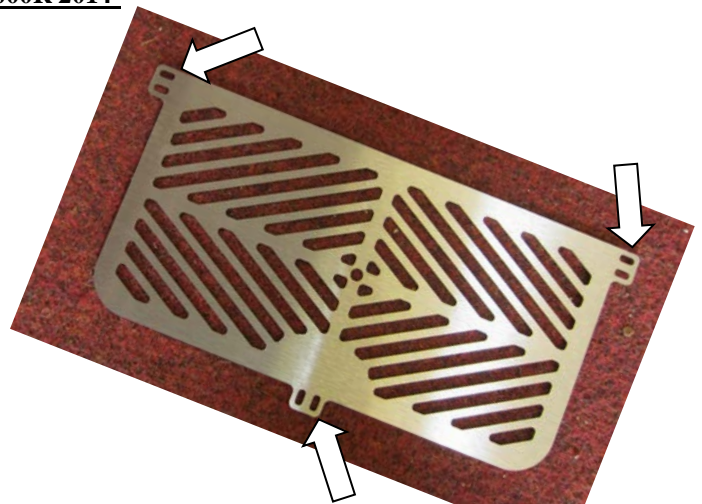
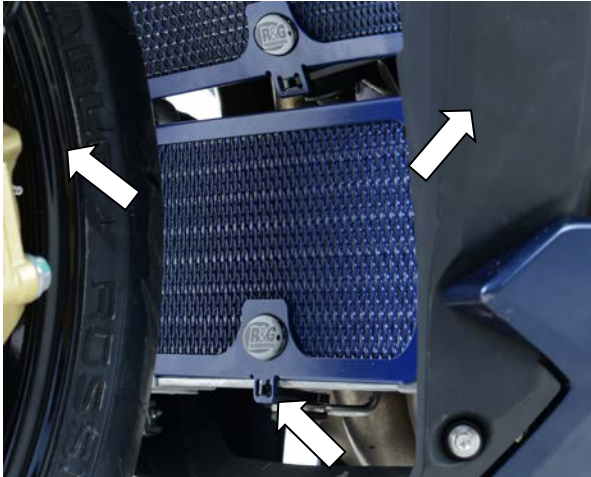

Dieser Kit beinhaltet:

1x Kühlerschutz
6 x Kabelbinder
2x 100mm selbstklebende Schaumstoffstreifen

- Um den Kühlerschutz am Motorrad zu montieren, schneiden Sie zuerst die mitgelieferten Schaumstoff-Streifen in 10 mm breite Streifen und kleben Sie diese auf der Rückseite des Kühlerschutzrahmens, so dass sie zwischen dem Kühlerschutz und dem Kühler angebracht sind. Die zwei Kabelbinder durch die Öffnungen oben (am Ölkühlerschutz) einführen und um die Montagehalterungen binden, wie oben abgebildet. Die übrigen Kabelbinder am Ölkühlerschutzrahmen unten, wie abgebildet, anbringen.
- Einige Ersatzkabelbinder für den späteren Bedarf sind im Lieferumfang enthalten.
