

FITTING INSTRUCTIONS

- Assemble the components as shown in the assembly diagram
- Thread the bolt into the threaded hole in the side of the swingarm, ensuring the small spacer sits inside the recessed area in the swingarm.
- Repeat for the other side of the bike.
- Ensure all bolts are torqued to the specs outlined on page 2.
- Always ensure all bolts are tight before riding.


