

FITTING INSTRUCTIONS FOR ECS0007BK ENGINE CASE SLIDER BMW K1200 GT '06-



Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – the rubber washers should be thrown away!

Nearside (Left Side as you Sit on Bike)

- Remove the four bolts that hold the clutch housing to engine. DO NOT REMOVE THE HOUSING.
- Place the R&G protector over the top and fix using four of the M6x30 button head bolts supplied.

Notez que si les kits sont emballés avec des rondelles en caoutchouc servant à tenir les composants, ces rondelles doivent être jetées.

Coté gauche assis sur la moto

- Enlever les 4 boulons qui fixent le carter d'embrayage au moteur. NE PAS RETIRER LE CARTER.
- Placer la protection R&G autour du haut et fixer en utilisant 4 des boulons M6x30 fournis.
