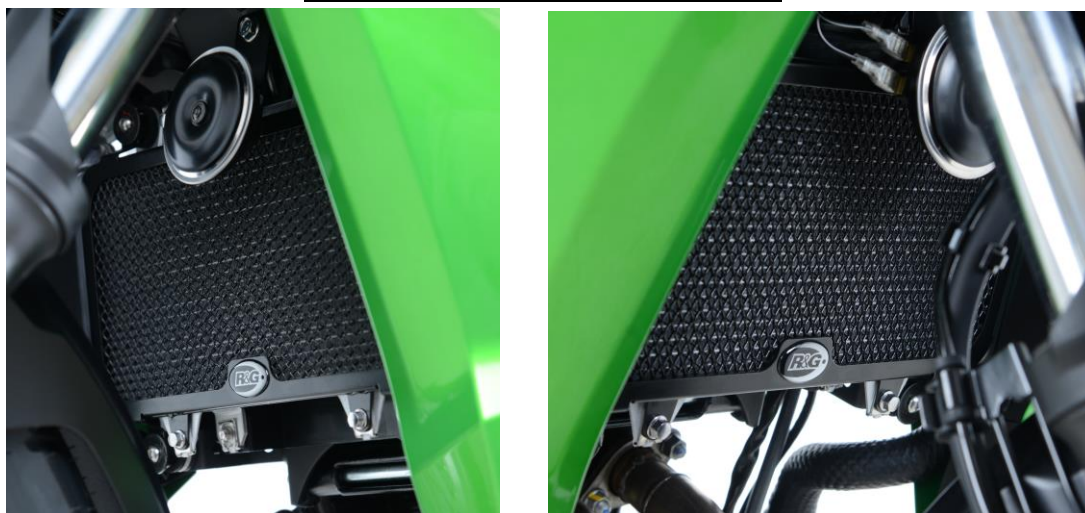




FITTING INSTRUCTIONS FOR RAD0221 RADIATOR GUARD

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – *the rubber washers should be thrown away!*

GENERAL TORQUE SETTINGS

M4 BOLT = 8Nm
 M5 BOLT = 12Nm
 M6 BOLT = 15Nm
 M8 BOLT = 20Nm
 M10 BOLT = 40Nm

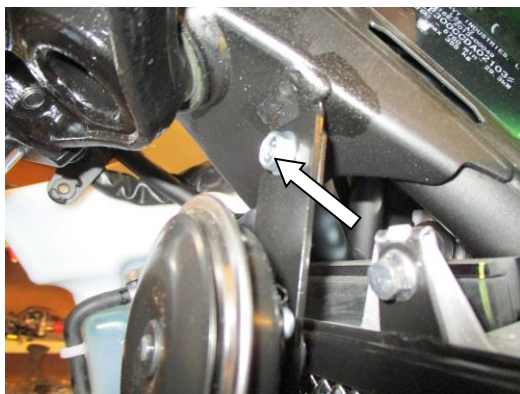
- Socket set to include 10 socket and wrench or spanner.

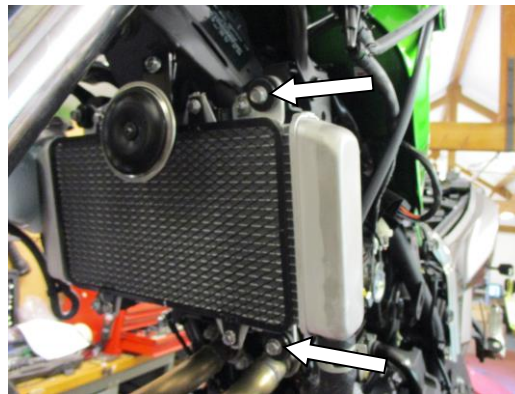

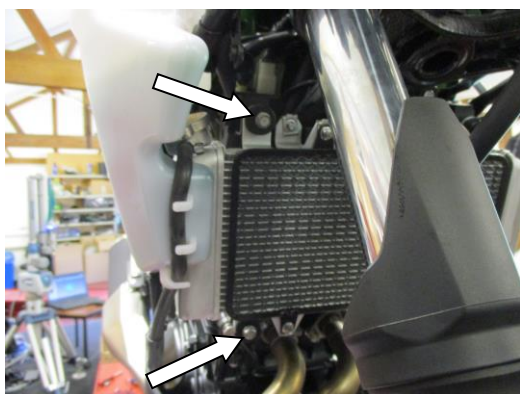

FITTING INSTRUCTIONS

- To fit the radiator guard to the bike, cut the foam strip provided into 10mm wide pieces and stick them to the back of the radiator guard frame, so that they sit between the radiator guard and the radiator.

- Loosen the horn mount bolt arrowed in picture 1 (do not remove) to aide fitment of the new radiator guard.
- Remove the four radiator mounting bolts (these have captive washers) arrowed in pictures 2 and 3.
- Offer the radiator guard into position as shown in picture 4 and secure using the original bolts (with washers) as shown in pictures 4, 5 and 6.
- Tighten the horn mounting bolt.

NOTICE DE MONTAGE

- Couper le bandeau de mousse fourni en pièces de 10mm puis collez-les au bas du cadre de protection radiateur, de façon à ce qu'elles se placent entre la protection radiateur et le radiateur.
- Desserrer le boulon du support de capot, voir photo 1 (ne pas enlever) pour faciliter l'installation de la nouvelle grille de protection radiateur.
- Enlever les 4 boulons de fixation radiateur (ils possèdent des rondelles) voir photos 2 et 3.
- Monter la grille de protection radiateur en position, voir photo 4 puis fixer à l'aide des boulons d'origine (avec rondelles), voir photos 4, 5 et 6.
- Serrer le boulon de fixation du capot.
