**FITTING INSTRUCTIONS FOR BLP0033BK GRAB-RAIL BLANKING
PLATES
GENATA XRZ 125 2013-**

Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – *the rubber washers should be thrown away!*

TOOLS REQUIRED

- 5mm metric Allen key.
- 10mm Socket and wrench.

FITTING INSTRUCTIONS

- Remove the pillion seat as shown above.
- Remove both rear grab-rails by removing the bolts as shown above.
- Peel and apply a strip of the supplied double-sided self-adhesive tape around the outer edges of the blanking plates so when the blanking plates are in position the tape sits between the blanking plates and the rear seat cowl (this is to prevent the plates vibrating and marking the panels).
- Peel the tape and fit the blanking panels using gentle pressure to allow the tape to adhere and secure using the supplied bolts as shown above.
- Tighten evenly using 5mm Allen key.

Instructions de montage

- Enlever le siège passager comme indiqué ci dessus.
- Enlever les 2 barres de saisie en enlevant les boulons comme ci-dessus.
- Appliquer de l'adhésif double face sur les bords extérieurs des plaques d'obturation pour que lorsque les plaques d'obturation sont en position, la bande se trouve entre les plaques d'obturation et le capot de selle arrière (Pour empêcher que les plaques vibrent et que le carénage soit marqué).
- Monter les plaques d'obturation en exerçant une légère pression permettant à la face d'adhérer puis fixer la position en utilisant les boulons fournis comme ci-dessus.
- Serrer de façon égale, à l'aide d'une clé Allen 5mm.
