



FITTING INSTRUCTIONS FOR LP0052BK TAIL TIDY / LICENCE PLATE HOLDER KTM 690SM



Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – *the rubber washers should be thrown away!*

- Remove both seats, rear handgrips and rear left hand side panel (for access to wiring plug).
- Remove OEM licence plate holder (remove cable cover to gain access to three bolts).
- Disconnect wiring plug.
- If reusing OEM indicators, remove from OEM bracket.
- If not already fitted to new tail tidy, mount the OEM or R&G indicators (product code RG370) and new tail tidy light supplied in the kit (wiring may be tidied up by using heat-shrink supplied) and secure in place.
- Offer the tail tidy into position and insert the two longer spacers from the kit onto the front-most holes (so that the spacers fit between the tail tidy and the plastic under tray).
- Using the two button head screws from the kit, secure the tail tidy in place (do not tighten yet).
- Insert one of the OEM screws and the shorter spacer from kit through the rear-most holes (spacer goes between bracket and screw head) and secure tail tidy into place. Tighten all three screws.
- Reconnect new tail tidy light and the indicator wiring using connectors supplied if required (we suggest cutting OEM loom and reusing plug). Note: it may be necessary to use the resistors supplied in the kit to ensure indicators work at correct speed.
- Check all mechanical and electrical connections
- Refit the rear left hand panel, rear handgrips and both seats.
- Ensure all lights and indicators are working correctly before use.

Returns must be pre-authorized (if not pre-authorized the return will be rejected). Goods may only be returned direct to us if they were purchased direct from us (customer must prove if necessary). Otherwise to be returned to original vendor. Goods must be in re-sellable condition, in the opinion of R&G Racing. All returns are subject to a 25% restocking and handling fee (25% of the gross value exc. P&P – at the prevailing price at time of purchase). The customer must pay any and all carriage charges. No returns of discontinued products, unless within 14 days of purchase. This policy does not affect your statutory rights and does not refer to faulty goods.
